Due to the current health hazards, the City of Spearfish solid waste department will not be offering curbside pickup to residents during spring cleanup.

However, the free drop off days at the Restricted Use Site (RUS) have been extended.

**Fees will be waived for all acceptable items April 27th.**

**Items accepted at the RUS:**

- Appliances & furniture
- Shingles or roof debris
- Batteries
- Gas & diesel pumps (fluids must be drained)
- Metal & iron
- Tires without rims
- Wood & sheet rock
- Household garbage
- Paint, hazardous or toxic waste
- Insulation
- Plastic
- Treated wood
- Barrels
- Styrofoam

### City of Spearfish Participates in Manganese Study

In addition to the annual drinking water report, the City recently participated in a statewide manganese in drinking water study. The following report was issued by the SD Department of Natural Resources (DENR):

"The City of Spearfish - Serving more than 10,697 customers an average of 802,275 gallons of water per day. The City supplies groundwater produced from local wells. The average manganese concentration in the drinking water is 0.02 mg/l. This concentration is below health advisory levels established by the United States EPA and considered safe to drink."

## Spearfish Police Department Drug Take Back Day

April 25th is National Prescription Drug Take Back Day sponsored by the Drug Enforcement Administration (DEA). The purpose of this event is to prevent pill abuse and theft by ridding homes of potentially dangerous expired, unused and unwanted prescription drugs. Bring your pills for disposal to Spearfish Police Department, located at 225 W Illinois Street, and dispose of them in the drop box. (The DEA cannot accept liquids, needles or sharps, only pills or patches.) The service is free and anonymous, no questions asked.
