Health Insurance

The City of Spearfish obtains health insurance through the Health Pool of South Dakota, which is administered by Wellmark. Those covered by the City's health plan have a vast in-network access to Wellmark's network of providers.

The City will cover 100% of the employee's plan premium and 75% of dependent plan premiums.

Each benefit-eligible employee receives a \$10,000 term life and accidental death and dismemberment policy.

Loan for Post-Secondary Education


All regular full-time employees who have completed their in-training period, are eligible to receive a loan up to \$2,000 from the City of Spearfish, repayable with a 1% interest rate. The loan must be for an educational program at an accredited educational institution.

Retirement Plan

South Dakota Retirement System (SDRS) is a 401(a) defined benefit pension plan that provides retirement, survivor, and disability benefits for South Dakota public employees. Full-time employees along with part-time employees who work 20 hours or more per week will participate in SDRS immediately upon hire. Employee's required contributions are based on SDRS regulations. Class B employees (public safety employees) contribute 8% of their gross salary and Class A employees contribute 6% of their gross salary with the City of Spearfish matching the employee's contributions.

The City offers PTO as a benefit to help promote a work-life balance for our employees. Employees accrue PTO time at increasing rates, based on the employee's length of service with the City.


